

SMIRNOFF ICE COOLER SOCIAL SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. MUST BE 21 YEARS OF AGE OR OLDER AND A LEGAL RESIDENT OF THE 50 UNITED STATES (EXCLUDING MAINE AND VIRGINIA) OR WASHINGTON, DC. VOID IN MAINE, VIRGINIA AND WHERE PROHIBITED OR RESTRICTED BY LAW.

1. The Smirnoff Ice Cooler Social Sweepstakes (“Sweepstakes”) begins on July 11, 2026, at or after 12:00 p.m. Eastern Time (ET) and ends on July 17, 2026, at 11:59:59 p.m. ET. (Actual start time for the Sweepstakes depends on when the Sweepstakes message is posted on the official Smirnoff Ice Instagram page, @smirnoffusa.)

2. To enter:

- a. From your public account on Instagram, “follow” @smirnoffusa if you do not already. As a requirement to follow @smirnoffusa, you must first verify that you are of legal age to consume alcohol beverages as per Instagram's functionality.
- b. Comment on the posted Sweepstakes message on @smirnoffusa with the hashtag #SmirnoffIceCoolerSweepstakes.

Total Approximate Retail Value of All Prizes: \$500.00.

Prize must be accepted in its entirety or not at all. Sponsor reserves the right to award elements comprising prize in multiple shipments.

Sponsor will determine the manufacturer, model number and features of prize elements in its sole discretion.

4. Winner Determination:

The random drawing will be conducted by Administrator, whose decisions will be final in all matters relating to the sweepstakes. Odds of winning will be determined by the total number of eligible entries received.
